FREQUENTLY ASKED QUESTIONS (FAQ)

- Q. Are participant incentives in the form of a gift card an allowable cost?
 - a. Yes
- i. Youth stipends for participation in the program are not allowed. The grant funds may not be used to pay youth to simply participate in or show up for programming. However, grant funding may be used to pay incentives. Should your budget include incentives, a policy must be in place that governs the terms and conditions associated with the provision of the incentives. This will need to be included with the proposal. At minimum, the policy must demonstrate:
 - a. The cost of the incentive program has been written into and approved in the grant budget.
 - b. The incentives are reasonable and necessary.
 - c. The incentives must equate to an achievement, for achievement of certain goals, milestones and training, or skill development activities connected to individual case plan goals.
- Q. Is there a limit on how much an organization can apply for in this NOFO?
 - a. No, awarded amounts are determined internally after submissions are received. The total amount of funding being awarded for this program will be \$2.125 million.
- Q. Are cooked and uncooked food allowable costs for the purpose of nutritional health and wellness training?
 - a. Yes, all food purchases must be associated with events or related to Training and education for the community and participants.
- Q. Is street outreach a required part of this service model?
 - a. No
- Q. If we are outside of the 8 identified service areas should we apply? We are located in South Shore.
 - a. All organizations that serve the highest risk communities in Chicago are encouraged to apply.
- Q. Is this pass through funding from ICIJA? If so, is this state funding or federal funding? We would be considered a subgrantee if granted the opportunity?
 - a. Yes, if an organization is selected for funding regarding this NOFO they will be considered a subrecipient.
 - b. This NOFO will be State Funded.

a. All links to the requested documents can be found on the NOFO form. There are icons on the document that serve as links to all downloadable files.

Q. Should we highlight work we've done in South Shore even if our primary location does not provide services to that community?

a. Yes, all communities served should be included in your application.
